- Meeting was called to order by President David Ganschow
- President's Report by David Ganschow – Thanks to all who helped in the success of Blackhawk in 2009.
- Treasurer's Report presented by Laura Rosenthal – Motion to accept report Larry Smith, Seconded by Keith Rosenthal, motion passed.
- Range Captain's Report presented by Jon Powell. Began by listing projects completed in 2009, the following were the projects proposed for 2010:
 - 3 Bunkers need replacing
 - 30 yard steps on first half need rail road ties
 - Practice bales need rebanding
 - Better wraps for housing 3D targets
 - Gravel needed for the driveway
 - Riding mower needs to be repaired
 - Clubhouse needs waterproofing/new roof
 - The inside of the clubhouse needs a ceiling below the roof

A proposal was made to have a meeting in July to determine our early shoot successes and how to finance a new roof for the clubhouse.
- New Business

- Discussion to get a sign for Blackhawk on Highway 16. To get a brown informational sign through the Department of Transportation, the cost is roughly \$1,000. Motion made by Ron Schmidt to pursue signage, seconded by Renee Powell, motion passed.
- Property Insurance on the Clubhouse and contents was discussed. The quote from Fleis Insurance included \$25,000 coverage on the clubhouse, \$25,000 coverage on the contents of the clubhouse. Property deductible \$1,000, annual premium \$485.00. Company Mount Morris Mutual. Motion to acquire coverage as presented made by Ron Schmidt, seconded by Renee Powell, motion passed.
- Broadhead Course – Discussion was made to set up a broadhead course on the second half of the range. Glenn Wood would be consulted this spring to look into the opportunities available.
