Hopefully we will be able to acquire adequate grant money to cover the bale expense this year. Motion to accept the treasurer's report by Ron Schmidt, seconded by Trevor Olson. Motion passed.

Range Report: There is a need for new bales this year for the practice range. Ron will go up to pick up the bales. There was discussion about closing the gap between the gate and the fence at the entry to the club. We will need to replace the fence down the roadside of the practice range and add No Trespassing signs as well along the roadway. We will also consider placing a pedestrian gate for those who do not want to enter the big gate. There will be a separate lock on the pedestrian gate, but the code will be provided to members. Work days will again be Saturday mornings in April from 8am until noon each Saturday.
